**Item 9. Other Events**

On December 22, 2021, Xurpas Inc. ("Xurpas" or the "Company") received a termination letter from Wavemaker Group terminating the Subscription Agreement executed on September 20, 2020 due to the following matters:

- (a) No Closing occurred on or before December 31, 2020;
- (b) Xurpas shares, or the Subscription Shares, were not issued to Wavemaker Group; and
- (c) No stockholders' approval was secured for the listing of the Subscription Shares.

Wavemaker Group likewise informed the Company in the same letter that the Stock Purchase Agreement executed on September 20, 2020 wherein Xurpas will purchase Wavemaker Shares in Wavemaker Group shall also be automatically terminated for failure to close on or before December 31, 2020.
